Dear Potential Vendor,

Christ Lutheran Church is planning to host the 2021 Pewaukee / Lake Country Farmers' Market. By signing the application, you are agreeing to follow the Guidelines set forth by the 2021 Pewaukee / Lake Country Farmers' Market.

Enclosed with this letter are the 2021 Vendor Application and the Market Guidelines. The location of the Pewaukee / Lake Country Farmers' Market will be Christ Lutheran Church's parking lot. All stalls will accommodate a **10'x10' tent**.

The spaces are numbered on the pavement. Do not go past the markings at the front of your space. Every effort will be made to create an appropriate marketing environment.

Hours for the Pewaukee / Lake Country Farmers' Market are Wednesdays from **3:00 pm to 7:00 pm**, May 12 through October 13, 2021.

- **Daily Vendors** (May 12 – Oct 13) \$40 per Wednesday
- **There will be an Early Bird Discount of \$100 from above prices if full payment, application and certificate of insurance liability for \$100,000/\$300,000 aggregate is received before March 15, 2021.**
- **Vendors sending in their application after March 16, 2021 will pay full price.**
- Craft vendor prices are the same as above, but their applications will be processed after the produce and food vendors' deadline. Craft vendors are allowed to compose approximately 10% of the Farmers' Market vendors. **Craft vendors must supply photos of themselves creating and assembling their items before applications will be approved.**

Off-Peak Season is often difficult for produce farmers to have a large variety of product. We anticipate Off-Peak Season may include a higher percentage of flower vendors, arts & crafts, baked goods, etc.

Not all spaces have room to park a vehicle. For loading and unloading however you will be allowed to pull up as close as possible and then park your vehicle in the designated vendor parking area. All vehicles need to be out of the market footprint by 2:30 pm. Please read the application carefully.

The application has a line to mark whether you must have your vehicle with you or not. If you do not absolutely need your vehicle, vendors will have a greater chance of getting a space if you're able to fill one of the non-vehicle spaces. We charge extra for the season to have your vehicle in your spot.

The Pewaukee / Lake Country Farmers' Market will open on Wednesday, May 12, 2021. It is important to have the vendor stalls full on that day. Even if your potential product is not available for purchase that day, we strongly encourage you to attend. Please consider providing information on the products that you will have available during the season. Produce vendors will be limited to two spaces.

Food and other vendors are usually limited to one space. Priority will be given to produce and food related vendors seeking Full Season and Peak Season space unless approved by market management.

Vendors wanting to rent space on a *daily basis* must complete the application and provide a Certificate of Liability Insurance, \$100,000/\$300,000 aggregate, listing Christ Lutheran Church and the Pewaukee / Lake Country Farmers' Market on the certificate as Additional Insureds. They must indicate that they will be a Daily Vendor at some point in the season. Vendors are strongly encouraged to pre-register. After registering, Daily Vendors pay on the day of their attendance providing there is space available. The Daily Rental Fee is \$40. Daily Vendors should apply well before the dates they want to come to the market to make sure they are approved as a vendor.

No brokers, agents, tiered sales, or commissioned sellers will be approved as vendors.

If you are a new food vendor, you must include the necessary permits from the Health Department or your application will not be accepted. If you have any questions, contact the Waukesha County Division of Environmental Health at (262) 896-8326 and ask for Trevor Quandt. You must also provide a 30 gallon or larger receptacle to accommodate waste.

Vendors who intend to use a generator must indicate that on the application form. Generator use at the Market will be limited. You must have prior written or emailed permission from the Pewaukee / Lake Country Farmers' Market to run your generator. Generators will be inspected by Market Management for noise level, fumes, disturbance to neighboring vendors, and safety. Inspections may be made throughout the season. If your generator does not meet approval, you will need to make arrangements for an alternative power source the following week. If your generator is deemed an immediate safety problem, you will be asked to stop the generator immediately. On a space available basis in following weeks, your stall assignment may be reassigned to a more appropriate location to run a generator. Use of a generator always requires approval from the Farmers' Market management team.

Final vendor approval and vendor locations in the market will be at the discretion of Market Management. **Once you are assigned your space it will not be changed.** Unresolved disputes over issues can result in cancellation of a vendor's contract.

Please note: With your application, you must provide copies of all licensing required by the State of Wisconsin and Waukesha County as well as a Certificate of Liability Insurance listing Christ Lutheran Church and the Pewaukee / Lake Country Farmer's Market as Additional Insureds.

- **Applications are due by March 15, 2021 to receive the \$100 Early Bird Discount.**
- **Vendors sending in their applications and payment after March 15, 2021, or without their permits and proper Certificate of Liability Insurance will pay full price to participate in the market.**

When completing your application, please include the exact address where the produce is grown (not intersections or city only). Incomplete applications will not be accepted. Upon signing the form, you agree to an on-site inspection of your growing area and cooperation with the Market Management team.

LOCAL PEWAUKEE / LAKE COUNTRY Service Organizations, Community Partners and Non-Profit Guidelines

The Pewaukee / Lake Country Farmers' Market has designed a space and an environment to best fit the community that the market serves. To make and keep that environment matching the design, the market management, without prejudice, will choose to accept vendors, service organizations, community partners and non-profit organizations to support their function. These organizations must follow the guidelines as shown below.

- Non-profit participants must provide their non-profit EIN number and official non-profit corporation name for verification purposes. The Pewaukee / Lake Country Farmers' Market reserves the right to verify your non-profit status.
- All organization must have an application on file with Pewaukee / Lake Country's Farmers' Market before attending the market.
- Each organization may only participate, during the duration of the 2021 market, four times, providing that their requested dates are approved.
- Each organization may participate at the market no more than once each month, providing dates approvals. Exceptions need approval by the Farmers Market Management.
- Participants from the organization may not wander around the market distributing materials, nor should they approach customers beyond six feet of their assigned booth space.
- Participants may not sell or give away any food or drink at the market.
- Any sale of products must be approved by the market management and may not compete with market vendors.
- Organizations should distribute the Farmers' Market flyers, along with any of their own materials.
- The location for setup will be chosen by the market management.
- Organizations must supply their own table and chairs. Set-up participants must be at the market by 2:00 pm on Wednesdays.
- **In Lieu of a fee or donation to the market we ask you to promote the Pewaukee / Lake Country Farmers' Market on your website and marketing materials.**
- Please provide market management with a certificate of insurance along with your application **Listing Pewaukee / Lake Country Farmers' Market and Christ Lutheran Church as Additionally Insured with limits of \$100,000/ \$300,00 Aggregate.**

We appreciate your assistance in creating the proper market environment. The market management recognizes that each and every organization plays a vital part in showing the cooperation and collaboration that makes the Pewaukee / Lake Country Farmers' Market a true and deserving destination for our wide-ranging community. Please remember that the market management retains the rights to modify booth selection and conditions at any time.

2021 Pewaukee / Lake Country Farmers' Market Guidelines

- Every vendor participating in the 2021 Pewaukee / Lake Country Farmers' Market **MUST HAVE** a Certificate of Liability Insurance, \$100,000/\$300,000 aggregate, **listing Christ Lutheran Church and the Pewaukee / Lake Country Farmers' Market on the certificate as Additional Insureds.** Your insurance provider can provide you with this certificate. Vendors will not be allowed to participate in the market without the Certificate of Liability Insurance which must be provided to Christ Lutheran Church before the market begins on May 12, 2021.
- The Pewaukee / Lake Country Farmers' Market hours are 3:00 pm – 7:00 pm on Wednesdays from May 12 through October 13, 2021.
- Any on-site concerns should be directed to the Farmers' Market Management who are at the Market Information Booth.
- Pewaukee / Lake Country Farmers' Market welcomes vendors to participate who offer agriculture or craft-based products. No vendor is welcome to participate who has political or lifestyle-based agendas. All clothing, banners, and display materials must also reflect a non-political and /or non-lifestyle-based agenda. All vendor clothing must reflect modesty. Any vendor will be asked to leave if these requirements are not honored.
- Pewaukee / Lake Country Farmers' Market requires that all farmers/vendors produce 100% of the products they sell. Vendors shall sell only items that have been approved on the Application submitted. The Farmers' Market has sole discretion to add or delete items from the list. The sale of any goods not grown or produced by the vendor is prohibited. Products shall be locally grown, have seasonal integrity and are of high quality. Persons selling must be family members or paid employees. No brokers, agents, or commissioned sellers may sell produce or products at the markets. **Violation of these rules could result in suspension of your permit for up to one year. Vendors shall make available for inspection those lands or areas on which produce or products sold at the market are raised or produced.**
- **Vendors selling processed food products must provide a copy of their retail food license or food processing plant license at the time of application, this does not apply to those under Wisconsin's Pickle Bill. If any vendor is deemed to be in violation of health codes pertaining to such products the vendor will be immediately removed from the market for the day and the proper regulatory agency notified.**
- Vendors and their employees shall conduct themselves in a pleasant and courteous manner to other vendors, customers, and Farmers' Market management. Foul language, profanity, or other rude behavior is not permitted. Vendors must cooperate with Farmers' Market Management following all rules of operation.
- Radios may not be used during market hours. Broadcasting of any type of sound or music must first be approved by Christ Lutheran Church Farmers' Market Management. Live musical groups must apply and be placed on the Farmers' Market Calendar. All playlists must be submitted for approval.
- Vendors are responsible for collecting and paying any sales tax that may be assessed on their products. Vendors shall be solely responsible for filing any and all returns required by state or local governmental authorities.
- The Farmers' Market site will be located at Christ Lutheran Church's parking lot in Pewaukee. Approved vendors will receive their stall assignments and vendor maps at the **Vendor Meeting on May 5, 2021**. Notices will be mailed through USPS by request only. Produce vendors may request a maximum of two (2) stalls and exceptions must be approved by market management. All other vendors are limited to one stall. Each regular stall will accommodate a 10'x10' tent. The spaces are numbered on the pavement. Do not go past the markings at the front of your space. The marks are there to provide an adequate amount of space in the event an emergency vehicle needs to get through. Every effort will be made to create an appropriate marketing environment.

- The Market Manager will be on-site by 1:30 pm each Wednesday. **All vendors must be parked by 2:00 pm and will remain until 7:00 pm.** Vendors may not be able access to their regular stalls after 2:15 pm. Stalls will be filled with Daily Vendors at 2:15 pm as necessary. Vendors not coming to the market must notify the Market Management at 262-737-6170 by 12:00 pm the Tuesday before the market date. After 12:00 pm on Tuesday and on Wednesday by 8:00 am, call the Market Management if you are not coming. You will be given the contact information before May 12. If you are not at the Farmers' Market and we have not been contacted by you by 2:15 pm your stall may be given to a daily vendor. For the safety of other vendors/pedestrians, if you arrive after 2:15 pm you will not be allowed to drive into your space, and your product will have to be hand carried. See market management about safe entry into the market. Vendors who do not abide by this guideline may lose their stall assignment preference in 2021. Please cleanup immediately following event. All vendors must be cleaned and packed up by 7:30 pm.
- Only locally grown, in-season produce, and flowers may be sold at the Farmers' Market. No wholesale loads of produce may be marketed. No brokers, agents, or commissioned sellers. Selling products not locally grown and/or crafted in Wisconsin may result in expulsion from the Farmers' Market, by signing your application, you agree to participate in random location inspection.
- Baked goods, canned goods, and on-site prepared foods must follow all Health Department rules. Necessary permits must be included with your application. For further assistance, please contact Environmental Health Sanitarian, at (262) 896-8326 and ask for Trevor Quandt. Inspections are performed by the Waukesha County Division of Environmental Health.
- **If you are a food/beverage vendor and your booth generate waste you must provide a 30 gallon or larger trash receptacle. Each vendor will receive one warning for failing to provide the required trash container, each subsequent occurrence will result in a \$25 fine.**
- Locally made arts and/or crafts may also be sold at the Farmers' Market. All products must be handmade. Craft items will be reviewed and will be rejected if found to not be handmade. All craft vendors must provide photos of you creating and assembling your items before your application will be approved. No flea market-type items are allowed. Non produce vendors are limited to one stall during peak season. Priority will be given to food and garden related vendors seeking Full Season and Peak Season stalls.
- Vendors are required to abide by all Federal, State, County or City laws and regulations regarding the sale of their goods. Copies of all required licenses and/or permits must be with you while attending the Farmers' Market.
- No livestock may be sold.
- When items are being sold by weight, an accurate scale must be used. Scales are subject to inspection by the Wisconsin Department of Agriculture.
- If serving food, which may leave grease drippings on ground, please place cardboard on the ground to collect drippings and provide the required trash containers to accommodate waste.
- **Smoking** by vendors is **not permitted** on the grounds of the Farmers' Market.
- Vendors may not bring pets and/or animals to the Farmers' Market.
- No alcoholic beverages and no firearms are allowed in the Farmers' Market.
- Please do not leave children unattended.
- Vendors are required to park in assigned vendor parking.
- We will offer gift certificates for the Farmers' Market and you agree to accept them by being a Farmers' Market vendor.
- **Garbage & Recycling: We require each vendor to supply a 5 gallon or larger container to be placed at the front of their booth.** The information booth will supply garbage signs. All vendors are expected to clean up & sweep their stall area after each market and **take their garbage and recyclables with them.** Failure to do so will result in a service fee of \$25.00 per occurrence. *****The Christ Lutheran Church garbage cans are NOT an option for vendors***.**

- Vendors found placing waste in the Christ Lutheran Church trashcans will be subject to a \$50 fine from the Farmers' Market. If a vendor is found placing waste in the Christ Lutheran Church trashcans a second time, they will be expelled from the Farmers' Market for the remainder of the 2021 season.
- **GENERATORS:** Vendors who intend to use a generator must indicate that on the application form. Generator use at the Market will be limited. **You must have prior written or emailed permission from the Pewaukee / Lake Country Farmers' Market Team to run your generator.** Generators will be inspected by Market Management or staff for noise level, fumes, disturbance to neighboring vendors, and safety. Inspections may be made throughout the season. If your generator does not meet approval, you will need to make arrangements for an alternative power source the following week. If your generator is deemed an immediate safety problem, you will be asked to stop the generator immediately. On a space-available basis in following weeks, your stall assignment may be reassigned to a more appropriate location to run a generator.
- Vendors must cooperate with the Farmers' Market Management and obey all guidelines. IF a problem is reported or observed, a vendor will be notified verbally, and then in writing, stating the problem. Failure to respond to the problem will result in termination of the vendor at the Pewaukee / Lake Country Farmers' Market without any refund of any fees
- A vendor identification sign will be assigned to you. This sign is the property of the Pewaukee / Lake Country Farmers' Market and its purpose is customer navigation and vendor identification. **All vendors are required to display this sign in a prominent place in your booth while open in the market.** You will be charged \$10.00 for a replacement sign should the sign assigned to you become lost or destroyed. Repeated failure to display the sign in your booth will result in warnings and possible market termination for the season.
- Vendors may not offer food or drink items as promotional giveaways without prior approval from the Farmers' Market Management.
- **Tents/Displays/Booths must be appropriately weighted down at all times. Vendors will be given one warning for their first violation of not having their booth appropriately secured. Subsequent violations will result in a \$25 fine per occurrence.**

You can sign up to perform for more than one Wednesday during the six-month run of the Market. Please indicate on your application what days and times you are available to perform. You do not need to be available for the entire 3 hours of the Market, although that is an option. We can schedule more than one group of musicians for any particular Wednesday.

While the Market DOES NOT pay its musicians to perform, you will benefit from the exposure you will get while playing at the Market. Thousands of marketgoers attend our Market each week. You are welcome to

put out a tip jar and sell any CDs, t-shirts, or other items you may have to promote yourself or your musical group. You are also welcome to offer any printed material you have such as business cards or brochures.

We will provide a 10x10 canopy tent which will be set up ahead of your arrival along with a generator or electric hookup. You must bring your own chairs, music stands or any other equipment you need to perform. Farmers' Market management will be on hand to answer any questions you may have or to assist you with set-up.

Pewaukee / Lake Country Farmers' Market COVID-19 Guidelines **Dated February 1, 2021**

These are subject to change when new information is shared with the management team.

Farmers markets, like grocery stores are considered an essential food resource. Wisconsin's Safer at Home Order has exempted them from being closed and from the mass gathering restriction instituted as a result of COVID-19.

The Pewaukee / Lake Country Farmers' Market has decided to adopt these new guidelines in order to facilitate a safe opening of our market after consultation with the Waukesha County Health Department.

1. At this time, produce and product vendors will be permitted in the market as allowed by the State Order.
2. People will travel in a clockwise direction throughout the market.
3. No sampling of products will be allowed.
4. Vendor set-up will be modified to allow more space between selling areas.
5. Booth spaces will be modified to increase the space between vendors and customers.
6. Social distancing will be practiced throughout the market.
7. All prepared foods will be pre-packaged for takeout consumption.
8. Vendors will handle products until given to the customer.
9. All vendors will have hand sanitizer at their booths.
10. Customers are encouraged to bring their own individual hand sanitizer as well.
11. Parents are advised to closely supervise children while in the market. Children should always be kept within an arm's length of their parents.
12. If you are running a fever, coughing, or generally not feeling well, please stay home.
13. We are encouraging everyone to use common sense and act responsibly when attending the market.

Vendor Information

1. If you are not feeling well, please stay home. Contact market management at 262-737-6170 to let them know that you won't be coming.
2. We encourage you to have one person handling all money transactions.
3. Use individual bags for each type of product when possible.
4. Clean and disinfect tables and surfaces, including tablecloths, when setting up and as needed.
5. Use single use gloves when they are warranted.
6. Avoid touching hands to the face, nose, or eyes.
7. Please advise customers of correct cleaning procedure for any products purchased.
8. Vendors that have any concerns about coming to the market should contact the market manager.
